



Dialog with Debbie

- * Fostering Futures Who taught you how to do a budget? Open a savings account? Fill out an application? Sort and wash clothes? On and on and on... For many of our 13 to 18 year old CASA Children, the opportunity to learn these life skills often goes untrained for them. Thankfully, we have Janice Petrey and we have Fostering Futures! Janice's "Program In a Box" life skills training modules offer hope and a better future to many children. If you know of someone who would be great at teaching or assisting teens in these life skills, let your Advocate Coordinator know. They do not have to be an Advocate to teach a lesson! This program is funded by the Houston Endowment Grant.
- * Finding Family As Kevin Campbell, founder of Finding Family says, "You have 12 brothers and sisters? Your parents must have been nuts!" I always answer the same, "No, they were not, they were following God's plan for them and I would not have wanted it any other way!" Imagine no realized family at all. Imagine never having that connection. As you know, many aged out CASA children never have that connection, but thanks to Finding Family, a program that seeks to build and maintain a lifetime Family Support Network, many kids may now be able to have the safety, security, comfort, identity and dignity to claim a sustained family unit. Making this work is not a science, it is an art, often complex, but very worthwhile. I urge you to contact your Advocate Coordinator if you are interested; our next class is October 27. This program is funded by a Walmart State Giving Grant.

Advocate Mandates and Info

As we have learned in our training, paperwork is necessary for CASA to remain in compliance with their regulations. Listed below is a summary of the documentation that we should keep up-to-date or check regularly:

- Review Green Binder when visiting child
- Provide name and phone number of foster care agent to your Advocate Coordinator
- Provide name and direct phone number of counselor to your Advocate Coordinator
- After each visit/phone call, send summary email to Advocate Coordinator, CPS Caseworker, CPS Supervisor (Chris Vien), and Attorney AL
- Complete timesheet and spreadsheet at end of month and send to Advocate Coordinator

As you know, Texas CASA has a mandate that every child must be visited each month if they are within 2 hours of an Advocate. If the end of the month is coming and you think or know that you will not be able to visit, please let your Advocate Coordinator know ASAP. If you cannot visit, then, due to a new Texas CASA Board mandate, the Advocate Coordinator must visit by the 10th of the following month. With our children spread out across counties, it is important to give your Advocate Coordinator as much time as you can so they can plan to visit. Our visits and paperwork are very important to CASA!
